If the department receives a sufficient number of protests to require a hearing pursuant to section 16-4-207(4) (b), MCA, to determine public convenience and necessity, a hearing will be held in the county in which the proposed premises is located. All qualified protesters will be notified of the time, date and location of the hearing. Hearings are typically scheduled within 90 days following the protest deadline. If a sufficient number of protests to require a hearing are not received and all licensing criteria have been satisfied, the department may issue the license without holding a hearing.
