The Chippewa Cree Tribe (CCT) in accordance with Tribal policies is soliciting proposals from qualified accounting firms to perform the financial and compliance audit of the CCT and related enterprises in accordance with the Single Audit Act, OMB Circular A-133, Governmental Auditing Standards, and applicable federal, state or tribal laws and regulations. The Audit will cover the tribe's fiscal year end, September 30, 2018, with an option to extend the contract for up to two additional years. The tribe has several component units that require separate audits. The bid should include the cost for each component unit also.
