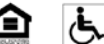

YOU ARE HEREBY NOTIFIED that a *Petition for Termination of Parental Rights and Permanent Legal Custody* ("the Petition") regarding, D.H., the child who is the subject of the above-captioned proceedings brought pursuant to Title 41, Chapter 3 of the Montana Code Annotated, has been filed in Cause No. DN-17-032 in Montana Twelfth Judicial District Court, in Hill County by the Montana Department of Public Health and Human Services, Child and Family Services (CFS), located at 232 1st Street West, Suite B, Havre, MT, 59501.

NOW, THEREFORE, YOU ARE HEREBY DIRECTED to appear at the hearing regarding the Petition that is set on the **23rd day of May, 2019, at 3:00 o'clock p.m.**, at the Hill County Courthouse, Montana, located at 315 4th Street, Havre, Montana, and there to show cause, if any you may have, why CFS should not be granted the relief requested in the Petition.

NOTICE: Your failure to appear at the hearing will constitute a denial of interest in the child, which denial may result, without further notice of this proceeding or any subsequent proceeding, in judgment by default being entered for the relief requested in the Petition.

You have the right to be represented by an attorney in these proceedings. If you are unable to afford an attorney, the Court will have an attorney appointed to represent you.
