The purpose of the meeting is to obtain public comments regarding the County's overall community development needs, including public facilities, economic development, and housing needs, and including the needs of low and moderate-income persons. The County will also seek the views of citizens on the activities that should be undertaken to meet the identified needs and their relative priority. 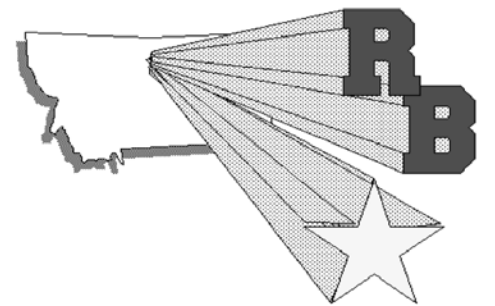
