SECTION 00100 INVITATION TO BID

Separate sealed bids for construction of BOULEVARD AVENUE WATER MAIN REPLACEMENT will be received by THE CITY OF HAVRE at the office of the MAYOR, 520 4TH STREET, HAVRE, MT, 59501, until 2:00 PM local time on Monday, August 24, 2020, and then publicly opened and read aloud.

The project consists of: Removing 6" Water main and replacing with 8" Water main and appurtenances between 11th Street and 9th Street on Boulevard Avenue in Havre and Removing 6" Water main and replacing with 12" Water main and appurtenances between 9th Street and Kober Drive on Boulevard Avenue in Havre and Installing 12" Water main and appurtenances between Kober Drive and Wilson Avenue on Boulevard Avenue in Havre and Abandoning an 8" CIP on 9th Street in Havre.

The Project Manual and Construction Drawings maybe examined or obtained at the office of the City of Havre, Director of Public Works, which is located at 520 4th Street in Havre, MT, 59501, in accordance with Article 2.01 of Instructions to Bidders. To obtain a copy of the contract documents, a \$50.00 refundable deposit is required. Refunds will be given upon return of full sets of the Project Manual and Construction Drawings.

There will be a Pre-Bid Conference at the Northeast Corner of Optimist Park (Kober Drive and Boulevard Avenue), Havre, Montana, at 2:00 PM local time on August 12, 2020. Interested CONTRACTORS are encouraged to attend.

The CONTRACTOR and any of the CONTRACTOR'S subcontractors doing work on this project will be required to obtain registration with the Montana Department of Labor and Industry (DLI). Forms for registration are available from the Department of Labor and Industry, P.O. Box 8011, 1805 Prospect, Helena, Montana, 59604-8011. Information on registration can be obtained by calling 1-406-444-7734. CONTRACTOR is not required to have registered with the DLI prior to bidding on this project, but must have registered prior to execution of the Construction Agreement. All laborers and mechanics employed by CONTRACTOR or subcontractors in performance of the construction work shall be paid wages at rates as may be required by the laws of Hill County and the State of Montana. The CONTRACTOR must ensure that employees and applicants for employment are not discriminated against because of their race, color, religion, sex or national origin.

Each bid or proposal must be accompanied by a Certified Check, Cashier's Check, or Bid Bond payable to the City of Havre, in an amount not less than ten percent (10%) of the total amount of the bid. Successful BIDDERS shall furnish an approved Performance Bond and a Labor and Materials Payment Bond, each in the amount of one hundred percent (100%) of the contract amount. Insurance as required shall be provided by the successful BIDDER(S) and a certificate(s) of that insurance shall be provided.

No bid may be withdrawn after the scheduled time for the public opening of bids, which is 2:00 PM local time on August 24, 2020.
