NOTICE CHIPPEWA CREE TRIBE OF THE ROCKY BOY'S RESERVATION 2020 PRIMARY ELECTION

NOTICE IS HEREBY GIVEN that filing will open for the candidates for the Chippewa Cree Tribe Business Committee on the 7th day of September 2020 at 8:00 A.M. The filing time will close on the 11th day of September 2020 at 4:30 P.M. There will be a total of one (1) position for the Chairman of the Business Committee and four (4) positions for the Business Committee.

To be eligible for membership on the Business Committee, candidates must have the following qualifications:

- Be a member of the Chippewa Cree Tribe.
- Must have physically resided within the general area, which encompasses the main body of the reservation or on any land under the jurisdiction of the tribe for two (2) years immediately prior to the date of the general election.
- Must be at least twenty-five (25) years of age on the date of the election.
- Should a potential candidate have been convicted of a felony in any state or federal court or convicted by tribal court of a misdemeanor involving dishonesty or bribery in handling tribal affairs, such persons shall not be entitled to be a candidate until five (5) years after completion of his penalty.
- If a candidate was ever convicted of use, possession or sale of illegal drugs in any state, federal or tribal court, such persons shall not be entitled to be a candidate until five (5) years after completion of penalty.

A petition for any tribal elected position shall be filed with the Rocky Boy's Chippewa Cree Election Board Clerk, located at the Chippewa Cree Tribal Office. Filing fees for any member who wishes to file as a candidate shall pay a filing fee as follows:

- For Business Committee Chairman-\$150.00
- For Business Committee Member-\$100.00

Request for Labor Proposal

Buffalo Court and Antelope Court Snow Removal 2020-2021

Buffalo Court Apartments located at 2351 5th Ave., and Antelope Court Apartments located at 2465 5th Ave. SE, are accepting labor proposals for snow removal for the 2020-2021 winter season. The proposal should specify **one flat rate per snow removal and one rate for sanding.** Snow will be removed any time there is a 2" or more accumulation and within two (2) hours of the end of a storm. Sanding of the grade for Buffalo Court will be from 5th Avenue to the property common drive intersection and shall be completed as needed to prevent ice buildup at the stop sign; sanding of the grade for Antelope Court will be from 5th Avenue to the first driveway and shall be completed as needed to prevent ice buildup at the stop sign. Snow will be removed from all sidewalks, paved streets and driveways. A walk through of the properties will be conducted on Wednesday, September 25, 2020 at 10:00 AM starting at the Community Center Building at Buffalo Court then proceed to Antelope Court.
