FBTHA is accepting proposals for an Auditor to perform a financial and compliance audit for the fiscal years ending **December 31, 2022, December 31, 2023 and December 31, 2024.** Contract for auditing service shall be in accordance with the Native American Housing Assistance Self-Determination Act (NAHASDA) of 1996.
