Notice is hereby given the Chippewa Cree Tribe is requesting proposals from qualified licensed Attorneys with Tribal Court legal experience to submit a proposal for the following:

- To conduct legal research and analysis of legal problems, develop resolutions, ordinances, interpret laws, rulings, and regulations for the Tribal Court, Chief Judge and Judicial Commission. Present facts in writing and verbally to the Chief Judge and Judicial Commission.
- Develop a Judges Bench Book.
- To create and amend Chippewa Cree Tribe Law & Order Codes for the Chippewa Cree Tribe of the Rocky Boy's Indian Reservation based upon findings and recommendations in the Feb 2020 and Sept 2022 Tribal Court Assessment.
- Work with CCT Attorney General, Court Administrator, Chief Judge and CCT Department Directors to identify other codes and ordinances that need to be created and amended.
- Submitted proposed codes to the Court Administrator for submission to the Chippewa Cree Tribe Business Committee.
- Submit an "itemized" bill to the Court Administrator on a monthly basis: including but not limited to time expended in conducting legal research, interpreting laws, rulings, and regulations for the Tribal Court, conference calls and/or meeting with staff members. Documenting all expenses incurred, including but not limited to: mileage, photo copies, faxes, and telephone charges on a monthly basis.

Proposal must include a resume and letters of reference. The majority of work shall be performed, completed, and managed under the direction of the CCT Office of Attorney General and Court Administrator/Executive Director. The project is a nine (9) month project. The Chippewa Cree Tribe reserves the right to negotiate final contractual terms with the successful respondent.
