CCT is seeking qualified firms to establish a contract, through competitive negotiations, to provide GIS Management Services that provide comprehensive solutions to address spatial needs for the Chippewa Cree Tribal Government and Departments.

The Rocky Boy's Reservation is home to the Chippewa Cree Tribe located in Northcentral Montana. There are approximately 3,800 people living on the reservation encompassing roughly 122,000 acres.
